

Terms & Conditions Spain (Mainland: Costa Brava, Costa del Sol, Costa Dorada)

Vehicle fleet provider is Europcar Rent-A-Car Spain. We kindly request you to read this information thoroughly. For further information please contact your travel agency.

INCLUDED IN THE RENTAL RATE

- UNLIMITED MILEAGE
- AIRPORT SERVICE CHARGES
- LIABILITY INSURANCE according to the conditions of the country where rental takes place
- EXCESS LIABILITY COVER (EXTENDED PROTECTION) UP TO 7,5 MILLION EUR: included, because the local amount covered is not high enough according to our standard.
- CDW INSURANCE (damage to the rental car): included, no excess.
- TP INSURANCE (theft protection): included, no excess.
- WINDOW-TYRE-UNDERCARRIAGE-ROOF COVERAGE: In case of damage you will pay the amount locally to the rental company and Sunny Cars will refund this after returning home. It is therefore not necessary to purchase an extra insurance locally.
- ADDITIONAL DRIVER: 1 included, every other additional driver € 8,89 per day per add. driver (max. € 63,54 per rental period). (maximum of 3 drivers are possible)

IMPORTANT ADDITIONAL RENTAL INFORMATION:

- PICK UP OUTSIDE OPENING HOURS: only on request possible for € 51,29
- DEPOSIT: Credit cards and EC-cards in renters name obligatory. The deposit is € 300. Please note: for categories . FB, FC, FU and MJ 2 credit cards are mandatory
- DRIVERS LICENSES: Each driver must have been in possession of valid drivers license for at least 1 year.
- MINIMUM AGE: minimum age is 25 years
- UNDERAGE SUPPLEMENT: 21 - 24 years possible for € 17,50 per day (max € 169,70 per rental period)
- EXTENSION: only when the local office agrees with the extension a new voucher can be sent with the

extension. A new reservation is not needed. The customer has to go back to the office and sign a new

contract, the rental company can ask for a new deposit. If the extension voucher is not sent, the

customer will be charged on his credit card.

- FINES: In case of a traffic fine, Europcar will charge you € 32,87 administration costs. If you pay for the FAW insurance (€ 2,94 per day) you can waive the administration costs away.

ONEWAY RENTAL / CROSS BORDER:

- NATIONAL ONE WAY RENTALS: on request only possible with charges, the charges will be provided upon confirmation
- CROSSING BORDERS: only on request possible to European Mainland, except: Gibraltar, Poland, Hungary, Bulgaria, Rumania, former Yugoslavia, Great Britain, Czech Republic and Slovakia.

- BABYSEAT [CSI infant seat] 6-11 month/-13kg: on request available: € 10,99 per day (maximum € 76,44 per rental). Replacement fee: € 80

- It is not necessary to buy any additional insurance (DVW, Super CDW, EXW) for the excess waiver coverage and damages to windscreens, tyres, the underside or roof of the car. Should you decide to take these optional insurances, Sunny Cars will not refund the charge.
